ORDINANCE NO. 2025-04

**AN ORDINANCE OF LOGANVILLE BOROUGH, YORK COUNTY, PENNSYLVANIA
AMENDING ORDINANCE NO. 96-1, THE REGULATING OF OPEN BURNING AND
THE PREVENTION OF AIR POLLUTION WITHIN THE TOWNSHIP, DEFINING
CERTAIN TERMS, AND ESTABLISHING BURNING OPERATIONS AND
REGULATIONS**

WHEREAS, the Loganville Borough Council (“Borough”) adopted Ordinance No. 96-1 (“Burning Ordinance”), regulating and restricting open burning within the Borough, on April 1, 1996; and

WHEREAS, the Borough desires to amend the Burning Ordinance to include additional, updated definitions and regulations of open-burning within the Borough.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Council of Loganville Borough, York County, Pennsylvania, under authority of law, as follows:

SECTION 1: The following shall replace Section 2 (E) and (F) of the Burning Ordinance and shall read as follows:

E. Subsections A and B of this Section shall not apply to the following fires:

- i. Fires on private property within the Borough solely used for the purpose of cooking foods using charcoal, wood, propane, or natural gas in cooking or grilling appliances.
- ii. Burning for the purpose of generating heat in a stove, furnace, fireplace or other heating device, that is compatible with laws governing such a device, within a building used for human or animal habitation.
- iii. The use of propane, acetylene, natural gas, gasoline or kerosene in a device intended for heating, construction or maintenance activities.

F. Subsection B of this Section shall not apply to the following fires: The use of a bonfire or campfire which is a fire less than six (6) feet in diameter and less than two (2) feet in height, built in the open air for warmth, entertainment, or celebration.

SECTION 2: The following shall be inserted to Section 2 as paragraphs (G) and (H) of the Burning Ordinance and shall read as follows:

- G. No person shall use such fireplaces or grills for burning of Designated

Recyclable Materials.

H. Outdoor fireplaces or outdoor grills shall not be used for purposes other than cooking food and shall not be used indoors or in any enclosed areas that are not properly ventilated (i.e. garages).

SECTION 3: Repealer. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4: Severability. If any provision or part of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid, such decision shall not affect or impair the validity of any of the remaining provisions or parts of this Ordinance. It is hereby declared as the intent of Council that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid provision or part had not been included herein.

SECTION 5: Effective Date. This Ordinance shall take effect immediately upon its enactment.
